## Definitions:

- 1. Eligible Monthly Availability Payment** is the Hourly Availability Rate times the number of hours in the operating month.
- 2. Actual Monthly Availability Payment** is the Hourly Availability Rate times the number of hours in the billing month times the ratio of availability of the resource over its SCC value.  
**Note:** When a Unit's performance is greater than its SCC value, Actual Monthly Availability Payment can be greater than Eligible Monthly Availability Payment
- 3. Revenue** is the sum of credits the unit received, including but not limited to UCAP, VAR, Black Start, and daily Energy Credits.
- 4. Reliability Agreement Monthly Payment** is the difference between the Actual Monthly Availability Payment and Revenue.
- 5. Hourly Availability Rate** is Annual Fixed Revenue Requirement (AFRR) divided by the annual non-outage hours.
- 6. Annual Fixed Revenue Requirement (AFRR)** is the dollar amount approved by FERC and is located in Schedule 4, Section 5 of the Reliability Agreement.
- 7. Reliability Agreement or Cost of Service Agreement.** A generic version of the Reliability Agreement is located in Market Rule 1, Appendix A, Exhibit 4. Actual agreements are made public and can be found at the following link:

- 8. Confidential,** in order to publish Reliability Agreement information at least three agreements are required per Reliability Region. Region 9004 is confidential since two out of the four agreements are retroactive adjustments.
- 9. Additional Reliability Agreement Information** is available on the Reliability Agreement Information website. Some of the documents are a Reliability Agreement Summary with Fixed Costs, a Status Summary of existing and pending reliability Agreements, and a yearly report of Monthly Costs.
